Information on Cookies

www.emcu.eu uses cookies to ensure the correct functioning of the procedures and improve the experience of using the services offered online.

This document provides detailed information on the use of cookies, how they are used and how to manage them.

- Definitions

Cookies are small text files (letters and / or numbers) that websites, when visited, transmit to the user's computer (tablet, smartphone, etc ...).

Cookies are stored by the browser (Firefox, Internet Explorer, Chrome, Opera, etc ...) as information to be reused during the visit to the site (session cookies) or in subsequent sessions, even after some time (persistent cookies).

Ultimately, cookies come stored, based on user preferences, by the single browser on the specific device used (computer, tablet, smartphone).

Similar technologies, such as, for example, web beacons, transparent GIFs and all forms of local storage introduced with HTML5, can be used to collect information on user behavior and the use of

services. Later in this document we will refer to cookies and all similar technologies by simply using the term "Cookies".

- Types of cookies

Based on the characteristics and use of cookies we can distinguish different categories:

• Technical Cookies.

These are cookies that are essential for the proper functioning of www.emcu.eu
They are used to guarantee and facilitate normal navigation and use of www.emcu.eu
These cookies allow, for example, to authenticate (automatic login), to remember some selected criteria such as the language, to remember the discussions already read in the forums, to collect some information in aggregate form about users, etc ...

Technical cookies can be temporary (session duration of navigation) or persist over time, even for months and even more (persistent).

Their deactivation compromises the effective use of some services (pre-set login, discussions already read, chosen options, etc ...).

Among the technical cookies we also find analysis and performance cookies, which are used to collect and analyze the traffic and use of the site anonymously.

These cookies do not identify the user and also allow you to monitor the system and improve its performance and usability. The deactivation of these cookies can be performed without any loss of functionality.

• Profiling cookies.

These are permanent cookies used to identify (anonymously or not) user preferences and improve their browsing experience.

• Third Party Cookies.

By visiting a website you may receive cookies from both the visited site ("owners") and from external sites managed by other organizations ("third parties"). Some examples are represented by the presence of buttons of "Sharing" or "like" relating to social media plugins, such as Facebook, Twitter, Google+ and LinkedIn, etc ... Other examples are: Google Analytics external statistics services; Google AdSense advertising banners, etc ... Basically these external services write cookies on the user's computer through the site that hosts them. The www.emcu.eu portal provides for the use of third-party cookies.

- Duration of cookies

Some cookies (session cookies) remain active only until the browser is closed or upon execution of the logout command.

Other cookies "survive" when the browser is closed end they are also available in subsequent visits by the user. These cookies are called persistent and their duration is set by the server at the time of their creation. In some cases, one is fixed expiry, in other cases the duration is unlimited. Where it is seen as a Persistent cookie it is therefore likely to be a different technology setting the cookie.

they can also write other profiling cookies by name and on behalf of advertisers, also variable over time

An example could be the .agkn.com domain which writes cookies: uuid (persistent for 5 years) and the u cookie persistent for one year. Another example is the .serving-sys.com domain which writes cookies: A6, C5, D2, u2 (with quarterly persistence). Other examples of persistent profiling cookies can be the domain .adnxs.com with the cookies anj .adnxs.com and sess, or the domain .yahoo.com with the cookie B. Obviously, other cookies are possible depending on the advertiser companies. By blocking Adsense (banner advertising) you also block these third-party cookies from third parties.

- Cookie management (enabling and disabling)

The user can decide whether or not to accept cookies using the settings on his browser. Attention: the total or partial disabling of technical cookies can compromise the use of the site features reserved for registered users. On the contrary, the usability of public content is also possible by completely disabling cookies. Disabling "third party" cookies does not affect navigability but could reduce the services offered (for example the buttons of the "share" of social media). The setting can be defined specifically for different websites and web applications. Furthermore, the best browsers allow you to define different settings for "proprietary" and "third party" cookies. You can avoid certain cookies by configuring your browser settings or by directly deactivating the part that manages and controls cookies. Here's how to proceed for the main browsers:

Google Chrome

- In the settings menu, select "Show advanced settings" at the bottom of the page
- Select the "settings content" button in the privacy section.

- In the tools menu, select "Options"

For information on how to manage cookies through other browsers, consult your documentation or online help files.

- More options for browsing without cookies Block third-party cookies

Third-party cookies are generally not essential for browsing, so you can reject them by default, through specific functions of your browser.

Activate the Do Not Track option The Do Not Track option is present in most of the latest generation browsers.

Websites designed to respect this option, when activated, should automatically stop collecting some of your browsing data.

As mentioned, however, not all websites are set up to respect this option (discretionary).

Activate the "anonymous browsing" mode Using this function, you can browse without leaving a trace of the browsing data in the browser.

The sites will not remember you, the pages you visit will not be stored in the history and the new cookies will be deleted.

The anonymous browsing function does not however guarantee anonymity on the Internet, because it only serves to not keep the data of browsing in the browser, while your browsing data will continue to remain available to website managers and connectivity providers.

Delete cookies directly There are special functions to do this in all browsers. However, remember that new cookies are downloaded every time you connect to the Internet, so the deletion operation should be performed periodically. If desired, some browsers offer automated systems for the periodic deletion of cookies.

This section describes the management methods of <u>www.emcu.eu</u>, with reference to the processing of users' personal data.

This information is intended for users who interact with the web services of www.emcu.eu.

The information is provided solely and exclusively for www.emcu.eu under discussion but not for other websites that may be consulted by the user through links on www.emcu.eu.

The information is also inspired by Recommendation no. 2/2001 that the European authorities for the protection of personal data, gathered in the Group established by art. 29 of Directive 95/46 / EC, adopted on 17 May 2001 to identify some minimum requirements for the collection of personal data online, and, in particular, the methods, timing and nature of the information that the data controllers must provide to users when they connect to web pages, regardless of the purpose of the connection.

THE "OWNER" OF THE TREATMENT

TYPES OF DATA PROCESSED

Navigation data The computer systems and software procedures used to operate www.emcu.eu acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols.

This is information that is not collected to be associated with identified interested parties, but which by their very nature could, through processing and association with data held by third parties, allow users to be identified.

This category of data includes the IP addresses or domain names of the computers used by users who connect to the site, the URI (Uniform Resource Identifier) addresses of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the operating system and the user's IT environment.

These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing. The data could be used to ascertain responsibility in case of hypothetical computer crimes against the site: except for this possibility, the data on web contacts do not persist for more than seven days, except for data voluntarily and explicitly provided by the user for specific services (registration and subscription to the newsletter).
